

Kerstmarkt 2024 Food Vendor Application

Hosted by Visit Pella December 5th – 7th

The 4th annual Dutch Christmas Market will be held at the Molengracht in Pella, Iowa.

Visit Pella is a 501©6 whose mission with our Kerstmarkt event, is to immerse our visitors in a world of Dutch culture, food, and craftsmanship, and experiencing a traditional, seasonal European Christmas market.

We accept applications from food vendors selling exciting, high-quality products, appropriate for outdoor festivals. Preferential consideration will be given to Dutch, Dutch-Indonesian or European foods, such as kroketten, patat friets, frikandel sausage, bitterballen, stroopwafels, drops (licorice, etc), popular Dutch soups, satay, nasi goreng, Belgium waffles, crepes and more. Variations of these classic Dutch foods will also be given special consideration. Our committee would be happy to advise you on additional ideas or variations of the items listed.

Please read the information below carefully, fill out all requested information, and submit it before the due date of **August 1st, 2024**. Space is limited.

2024 Kerstmarkt dates and times

How will vendors be selected? All interested in being a food vendor shall complete this application. We will need a photo of your trailer, food truck, and/or booth included with the application. Additional photos or information might be requested by the jury committee of your product. (Photos will be returned to you, if hard copies are mailed in, after jury process). Food vendors will be juried by a sub-committee of Kerstmarkt on the uniqueness of what they will offer. Upon acceptance, food vendors will be required to provide the vendor fee by October 1st along with their Certificate of Insurance. The application will be confirmed once the fee and insurance certificate is received.

Once your application is accepted, you will receive a packet with further Kerstmarkt information, rules, and regulations for the market. This packet will be sent to you November 15th. A delay in your payment and/or insurance will delay and may affect your acceptance into our market and a delay on receiving this packet.

Food Vendor Information

- Information needed will be on the application page and will include:
 - Name of the business
 - Electricity needs
 - Truck/booth size along with the size of space needed
- The Molengracht area will be reserved for Dutch themed booths (no food trucks) that serve Dutch foods and will be based on a first in availability.
- Non-Dutch food booths and food trucks will be on E. 1st Street. Food truck location is subject to change.
- Electricity is supplied to the truck/booth. But there will be no water supplied to the booths.
- We are not responsible for securing a Dutch themed booth or any other booth for food vendors.

What is my fee to participate as a Kerstmarkt Vendor?

Assignments

Food Vendor space is not confirmed until full payment has been received. Booth assignments are to be provided to vendors by November 15, 2024. At that time, we will also give you what length of cord is needed to reach the power source. You will need to provide cord cover for your own cords. Food truck location is subject to change. Vendor placement will be assigned to best benefit guests attending the market along with the vendor's success for sales and the overall success of Kerstmarkt.

Cancellation of the Event

Pella Kerstmarkt has the sole right and discretion to cancel or postpone the event. If the event's cancellation is inevitable, the vendor releases and forever discharges Pella Kerstmarkt and those involved, officials, volunteers, organizations, city, from any liability, loss, harm, and claims for damages, plus all claims whatsoever, which arise from such postponement or cancellation.
